SAFE SANCTUARIES POLICY HIGHLIGHTS

- No fewer than two adults (18 or older & out of high school) should be present in a gathering of one or more children (birth-5th grade) or youth (6th-12th grade) during any church-sponsored program, event, or ministry activity involving youth or children. If only one adult or two related adults is present at any time during a children's or youth ministry activity, event, or program, an adult "floater" should be present & will move unannounced in & out of all rooms where only one adult is present.
- No adult who has been convicted of child abuse (sexual, physical, or emotional) can volunteer to work with children or youth in any ministry-sponsored activity.
- Volunteers & staff persons working in ministry with children & youth must be at least two years older than any youth or child with whom they are working. Paid staff working with children must be 16 years of age or older. Paid staff working with youth must be 18 years of age or older.
- Adults should never be one-on-one with a child in a private setting. Adults who are with youth one-on-one should meet in public places. Doors should have windows where possible & should be left open if an adult is in a room with children or youth by themselves if the room does not have a window.
- Counseling sessions, undertaken by Munsey clergy, program staff, or volunteers with youth or children, will take place in a room with the door open throughout the counseling session.
- Any youth or children's program, ministry event, or activity will have advance notice to parents & guardians.
- Background checks are mandatory for all paid Munsey staff & for all volunteers with children & youth.
- Annual training on Safe Sanctuaries will be provided as part of orientation for the particular youth or children's ministry event or activity.
